

# FOOD SAFETY IN THE WORLD'S SALAD BOWL by Jeff Raifsnider

As California acts to address food safety, will conservation efforts suffer? In September 2006, an outbreak of the deadly E. coli 0157:H7 strain killed three people and sickened approximately 200 others in 26 states. This outbreak was traced back to spinach from San Benito County. Salinas Valley and adjacent valleys

have been involved with eight of the 19 E. coli 0157:H7 outbreaks associated with lettuce and spinach since 1995.

After the latest outbreak in spinach, the September 14, 2006 Food and Drug Administration (FDA) advisory against eating fresh spinach heralded an estimated \$1 million dollar a day loss for the spinach industry. The resultant media frenzy was followed by major industry layoffs, and a threat to consumer confidence in the food safety standards practiced in the area known as the "World's Salad Bowl." The Salinas Valley produces about three-quarters of the nation's lettuce and spinach.

California Department of Food and Agriculture (CDFA) officials announced the start of a new California State Marketing Agreement on January 24, 2007. The agreement is designed to

improve food safety standards for handling of spinach, lettuce and other leafy green vegetables in California and potentially to guide improved food safety standards that the entire nation will follow. Industry groups hope that the agreement's improved safety standards will increase consumer confidence and head off proposed new legislation that could increase production costs.

Under the Marketing Agreement, California handlers can agree to accept product only from farmers who follow specific food safety procedures in the growing of leafy greens. "Leafy Green Products" are: iceberg lettuce, romaine lettuce, green leaf lettuce, red leaf lettuce, butter lettuce, baby leaf lettuce (i.e., immature lettuce or leafy greens), escarole, endive, spring mix, spinach, cabbage, kale, arugula and chard. CDFA's announced start of the agreement means that handlers can now sign up to participate and enables CDFA to appoint a 13 member Marketing Agreement Board.

Product certified as grown under "Good Agricultural Practices" will be designated by an official "mark" or seal.

Some of the guidelines of the Marketing Agreement, such as monitoring of crop handling and testing of irrigation water and compost amendments will undoubtedly improve the safety of the food supply. However, significant uncertainty remains about the effectiveness of other guidelines, such as removal of all non-crop vegetation and elimination of wildlife cover in

buffer areas. These requirements contradict practices that provide environmental protection, and growers will be caught in the middle and forced to choose between these two objectives.

NRCS has been working cooperatively for years with local farmers and regulatory agencies to develop conservation practices to meet water quality and wildlife protection standards. The Farm Water Quality Planning program of UC-Cooperative Extension and NRCS, and the Agricultural Water Quality Alliance for the Monterey Bay National Marine Sanctuary have assisted farmers and ranchers to protect water quality on thousands of acres along the Central Coast. Growers who have installed vegetative conservation practices and have documented improvement in water quality may now be pressured to remove these practices to meet industry

guidelines calling for clean fields.

Vegetative conservation practices such as filter strips, grassed waterways, hedgerows, and vegetative barriers act to reduce soil and wind erosion, and to remove sediments, nutrients, chemicals, and animal waste from agricultural runoff. Conservation practices protect and improve water quality while protecting many threatened and endangered species.

The potential food safety benefits of the guidelines must be weighed against the known degradation of water quality and wildlife habitat that will occur if vegetative conservation practices are removed or if new vegetative conservation practices are discouraged and never installed. These issues highlight the need for better research and information on the pathogen transport mechanisms before adopting measures that have uncertain food safety effectiveness but known adverse environmental impacts.

In the long run, it is imperative that industry leaders work with the environmental regulatory agencies, researchers, and conservation technical assistance agencies such as the Conservation Districts, UC Cooperative Extension, and NRCS, to create compatible solutions that address both food safety and natural resource protection goals. Some scientific literature indicates that the biodiversity created from certain conservation practices acts to reduce disease vectors and organisms, not to increase them. Food safety and environmental protection measures may actually be complementary rather than in conflict as they currently seem to be.

#### CALIFORNIA AND NEVADA SWCS CHAPTERS PLAN TO MERGE

Ten members of the Nevada Chapter SWCS responded favorably to the recent letter signed by Acting Nevada Chapter President Cub Wolfe and CA Chapter President Mark Steffek asking their views on pursuing a merger. There were no unfavorable responses.

California Chapter members were notified of the potential merger in the last newsletter and invited to express positive of negative views by December 28. There were no unfavorable responses.

Since there is a favorable consensus by members of both Chapters, SWCS headquarters will be notified by letter and work initiated to amend the by-laws. The California Chapter Executive Council expressed hope that the merger can be completed at the next Business Meeting on May 3, 2007 in Sacramento.

The proposed name for the combined Chapter would be "California-Nevada Chapter SWCS" and all the California Chapter officers would retain their positions until their next election. The By-Laws Committee will also consider a suggestion to increase the number of Executive Council Directors from five to six and designate that at least one be filled by a member living in Nevada.


